

# Privacy Policy

## **1. We respect your privacy**

- 1.1. respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to Czech Republics Privacy Principles contained in the EU General Directions about Privacy Regulations. his policy sets out how we collect and treat your personal information.
